However, any funeral arrangements you select will include our fee for basic services. If legal or other requirements mean that you must buy any items you did not specifically ask for we will explain the reason in writing on the statement we provide to you describing the funeral goods and services you selected.

LICENSED PROFESSIONAL SERVICES

Basic Services of the Funeral Director and Staff

Our fee for the basic services of the funeral director and staff includes but is not limited to:

- 24-hour availability in responding to the request for service.
- Consultation and the arrangement conference.
- Examination of financial settlement options.
- Preparation of statistical and biographical data.
- Preparation and filing of papers, permits, and authorizations.
- Preparation and placement of obituary notices.
- Overhead expenses, relative to our facility and operations, such as occupancy, administration, and equipment costs.

The fee for our basic services will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.

Embalming

Except in certain cases, embalming is not required by law. Embalming may be necessary, however, if you select funeral arrangements such as funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require that you pay for it, such as direct cremation or immediate burial.

If you choose to have an embalming performed, the decedent may be embalmed at a location other than this registered mortuary.

Please note non-local automotive equipment charges for specific cemeteries are provided by our livery service. All limousine charges will include a 20% gratuity for the driver.

Note about limousines and their rates:

- A standard limousine holds 7 passengers, including one riding in front with the driver.
- 8-Passenger limousines, where one passenger rides in the front with the driver, are available for an additional charge of \$30 on local funerals and \$50 on out of town funerals.
- Any vehicle cancelled after 4:00 PM on the day before the funeral will be subject to a cancellation fee of \$100.00.
- Any vehicle cancelled the day of the funeral will be subject to the full charge of \$ 315.00
- Lunch stops will be billed at a rate of \$60.00 per hour (or \$15.00 per 1/4 hour)
- Vehicles hired more than 1 1/2 hours prior to the religious service will be billed \$15.00 per 1 /4 hour of additional time.

Cash Disbursements

These outside expenses include such items as newspaper notices, clergy honorariums, death certificates and cemetery charges. They will be itemized on the Statement of Funeral Goods and service selected.

OPTIONAL PACKAGE SERVICES

Direct Cremation

\$2,120.00 to \$2,195.00

Our package charge for direct cremation includes basic services of the funeral director and staff, the local (within 10 miles) transfer of the remains to the funeral home from place of death (other than a residence or other place requiring additional assistance), the basic sheltering of remains, the obtaining of necessary permits and authorizations, the local (within 10 miles) transportation and licensed accompaniment to the crematory, the alternative container for cremation. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to cremation, any sheltering on days when no post death activity occurs, or any embalming or sanitary care necessary for identification or viewing by the family or any other cash disbursement, such as newspaper notices, death certificates, disposition permit and the cost of the cremation or anything else not expressly stated as being provided.

If you wish to purchase a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials.

Our package for forwarding remains to another funeral home includes basic services of the funeral director and staff, the local (within 10 miles) transfer of the remains to the funeral home from place of death the basic sheltering of remains, standard embalming and obtaining necessary permits.

This charge does not include the use of facilities and staff for any Visitation or ceremony public or private, a casket or alternative shipping container, or any sheltering on days when no post death activity occurs. It also does not include transferring the remains to the airport or other destination or the charges of a common carrier, or any other cash disbursement or anything else not expressly stated as being provided.

Our package charges for Receiving remains from another funeral home includes basic services of the funeral director and staff, the basic sheltering of remains and the local (within 10 miles) transportation to and licensed accompaniment to the cemetery or crematory.

This charge does not include the use of facilities and staff for any visitation or ceremony public or private, or any sheltering on days when no post death activity occurs. It also does not include transferring the remains from Newark airport or other source or the charges of a common carrier, or anything else not expressly stated as being provided.

Immediate Burials

Our package charges for immediate Burial includes basic services of the funeral director and staff, the local (within 10 miles) transfer of the remains to the funeral home from place of death, the basic sheltering of remains, the obtaining of necessary permits and authorizations, the local (within 10 miles) transportation and licensed accompaniment to the cemetery.

This charge does not include the use of facilities and staff for any visitation or ceremony public or private, or any sheltering on days when no post death activity occurs or any embalming or sanitary care necessary for identification or viewing by the family or a burial vault if required by the cemetery. It also does not include the cemetery charges, newspaper notices, death certificates, the State required filing fee, the disposition permit or any other cash disbursement or anything else not expressly stated as being provided.
